President's Message The Three Legs of the Stool

The Pacific Grove Library is in the happy position of having three different volunteer organizations offering support: the Library Board, the Foundation, and The Friends. Each of these organizations has a distinct role to play in keeping the Library healthy, but it can be difficult to keep them straight. I thought it would be useful to devote this President's letter to discussing their respective roles.

A public library is supported with public money, i.e., money generated by taxes, fees, and other community income. As such, many public libraries also have public oversight. The Library Board is Pacific Grove's vehicle on this score. One of four boards created by the Pacific Grove City Charter (the others are the Planning Commission, the Museum Board, and the Recreation Board), the Library Board serves in an advisory capacity to the Council and City manager in matters pertaining to the Library's operation. The five members of the Library Board are appointed by the City Council.

Unfortunately, public money may not be sufficient to keep a library in healthy working order. The 1974 Articles of Incorporation for the Friends acknowledges this fact in identifying as one of its purposes "to solicit and encourage gifts, endowments, and bequests to the library." The impact of the Friends in this area is clear. Records from the early years of the Friends show an income of \$1000 to \$2000 per year, with money being spent on cosmetic improvements such as carpeting and drapes. Roughly thirty years ago, the Friends began its on going support of the summer children's reading program. In recent years, the Friends has contributed an average of over \$40,000 annually, some of which has gone for basic operations, books and materials. But this is only one of the functions intended for the Friends. Another is "to focus public attention on the library," and a third is "to support and cooperate with the library in developing library services and facilities for the community." In this role, the group spearheaded the 2009 and 2010 campaigns to pass a parcel tax dedicated to the Library, has relentlessly lobbied the City Council on the Library's behalf, and has sponsored efforts to help the Library adapt to new realities.

In 2010 the Friends Board determined that fundraising needs were swamping its other responsibilities to the Library and the community, and that the Library's fiscal needs were likely to stay at a level above what its annual income could reasonably support. The Foundation was established in 2011 with the sole purpose of providing a stable long-term source of supplemental funding. Although the Foundation will support some Library needs in the near term, its major focus at the moment is to build its assets. If the Foundation had assets of \$2 million, it could assure the Library of \$80,000 annually; if the Foundation had assets of \$5 million, it could assure the Library of \$200,000 annually.

In short, the PG Library is supported by an organization devoted to its operation, an organization devoted to developing and channeling community support, and an organization devoted to its long-term fiscal health. You can participate. When the City asks for Board member applications, apply. If you're a member of the Friends, ask your friends to join. When you plan your estate, think of the Foundation.

Library Board News

The Pacific Grove Library Board has been focusing its priorities in two main areas:

- The Library's Strategic Plan. We now have a framework for the Plan, and are proceeding to break down the key tasks, work, items and schedules. Next we will be asking for volunteers to lead each task, and then getting input from key stakeholders such as the library staff, the Friends of the Library (FOL), the Foundation, and of course the community.
- 2. The Library Board published a Space Needs Assessment and received bids from two professional companies. The goal was for a formal evaluation of the Library, as well as assistance with the community input area of the Strategic Plan. The cost of professional involvement from these vendors was prohibitive, so the LAB is working on an alternative plan with the interim Library Manager, City Council Representative Casey Lucias, and other City employees.

The Library Board continues its liaison activities with the library and city, as well as the FOL and the Foundation. A new member, Kristin Cushman, joined Carol Greenstreet, Larry Telles, Michael Cunningham, and Karin Locke on the Library Board in March.

Library Foundation News

The Pacific Grove Public Library Foundation (PGPLF) is finalizing its annual report for the calendar year 2012. An announcement will be forthcoming after it has been printed. The PGPLF board is also creating a brochure to be used as part of a donor campaign to be held in the fall.

The PGPLF board has applied for a grant from the Community Foundation for Monterey County to create a website that will provide information about the foundation, including its purposes and goals. We hope to have the site up and running later this year. In order to further define and clarify how the PGPLF, the Friends, and the Library Advisory Board can support the library and one another, the chair of the LAB and the presidents of the Friends and the PGPLF have instituted a program of periodic meetings to enhance communication about each group's activities and their respective goals. The head librarian is an integral part of these meetings. Working together, we can make our library stronger and enhance the services it provides to our community.

The board notes with regret the resignation of Michael Cunningham, as he moves back to Palm Desert to be closer to his family. We will miss his sound advice as Chief Financial Officer.

Meet the Author

An intimate crowd of about 35 attended the June 13 Meet the Author presentation, in which Alice LaPlante shared her inspiration for *Turn of Mind*. The main character—and the main suspect—in this mystery is Dr. Jennifer White, who has Alzheimer's. White doesn't remember the details surrounding her best friend's death, and the reader



learns them with her as images float in and out of her memory.

In writing this book, LaPlante drew from personal experience with her mother's struggle with this devastating disease. The murder mystery in *Turn of Mind* is compelling, but the true impact of the work lies in the depth of insight LaPlante offers into the effects of Alzheimer's on those who suffer from it and those who love the afflicted.

After the presentation LaPlante signed books provided by Robert Marcum of The Works, and the audience enjoyed refreshments.

LaPlante is a creative writing instructor at Stanford and San Francisco State universities. She is the author of five books and counting. Her new book, *Coming of Age at the End of Days* is due out this fall.

Dear Friends,


Believe it or not, it's been at least twenty years since the Pacific Grove Public Library received a fresh coat of paint. We are lucky it has held up as long as it has. On June 19, the City Council voted to award a contract for painting the outside of the Library. Because this is an historic and prominent building, the Architectural Review Board wants to ensure that the colors chosen reflect our library's rich heritage.

In researching the color of the original 1908 library building, staff found a treasure of historic documents and photos from when the Pacific Grove Public Library was still the "Carnegie Public Library." In addition to a news report from the time and photos of the building, the library has the original contractor bids and the build sheet. The build sheet specifies the finishes and formulas for the stucco and concrete, as well as the dimensions and specifications for a "fumigation closet" in the basement. It is difficult not to speculate on what purpose a fumigation closet might have served!

While these documents are fragile and require "white gloves" for handling, we would love to show them off to those interested. We hope to have a display sometime in the future.

In the meantime, keep an eye on the exterior of the building for a new coat of paint. And don't worry, unlike Tom Sawyer we won't be looking for unsuspecting passersby to help out. And, what might that fumigation closet have been used for?
